### Registering could raise money for your child's school

Registering for free meals could raise an extra £1,320 **per child** for your child's school, to fund valuable support for them for example: extra tuition if needed and additional teaching staff.

This additional money (Pupil Premium) is only available from central government for every child whose parent is receiving one of the welfare benefits listed in the form and who have registered this information with KCC Free School Meals Department either by:
